The permit will notate the date the permit expires and shall be placed in a visible area (i.e. dashboard) of the vehicle at all times.
- Failure to display the permit or remain in the parking area longer that the approved time, shall subject the vehicle to towing at the owner's expense.
- This Policy does not supersede any Local, County, State, or Federal ordinances.
